The Custodian is an hourly position and will work a varied schedule including early mornings, evenings, weekends, and holidays.

ESSENTIAL JOB DUTIES:

- **Facility Cleaning (Quality, Consistency)**
 - a) Complete detailed cleaning tasks with strong attention to sanitation, presentation, and safety.
 - b) Follow established cleaning schedules.
 - c) Properly use and maintain cleaning equipment and supplies.
- **Supply Monitoring & Facility Support (Consistency, Commitment)**
 - a) Monitor and track cleaning supplies; communication supply needs in a timely manner.
 - b) Communicate regularly with the Maintenance Supervisor and Assistant regarding facility needs, concerns, or repair issues observed during shifts.
 - c) Support seasonal facility needs, special events, and snow removal as assigned.
- **Safety & Compliance (Quality, Commitment)**
 - a) Follow all safety procedures and safe chemical handling procedures.
 - b) Identify and address potential hazards promptly.
 - c) Participate in required trainings and maintain required certifications.
 - d) Support compliance with health, safety, and facility standards and handbooks.
- **Teamwork & Continuous Improvement (Creativity, Commitment)**
 - a) Work effectively as part of the PAC team, contributing to a positive and respectful workplace.
 - b) Identify opportunities to improve cleaning systems, efficiency, and overall facility care.

- Previous custodial or maintenance experience preferred but not required.
- First Aid/CPR Certification (or ability to obtain within 90 days).
- Must pass a background check and any required drug screenings.
